Are You Ready to Go Digital?

February 17, 2009 is the deadline set by congress to switch from analog broadcasting to digital television. If you own an analog TV, which mainly relies on an antenna rather than cable or satellite to receive TV signals, you'll either have to switch to a digital model or buy a converter box that changes the digital signal back to analog.

These converter boxes will range in cost from \$50—\$75.00 each. The federal government is helping to defray this cost by providing coupons. Households may request up to two \$40.00 coupons to go toward the purchase of two converter boxes (1 coupon per box). The deadline to apply for these coupons is this month—MARCH

31st!!! You can call 1-888-388-2009 or go on line at www.dtv.gov to request your coupons or get more information.

If you are a cable or satellite TV subscriber you will not be affected by this transition. If you are like me act now and request 2 coupons, just incase your friend like me forgets!

Straight From Albany...

Tom Siembor, WTA's roving lobbyist, reporting on his recent trip to Albany states:

Gov. David Patterson is off to great start-looks like he's going to shelf some of the controversial budget items Spitzer introduced. That may be a really good thing.

NYSUT reps were out in force and made a very professional and very concerted showing on Lobbying Day. Most legislators made time for us, unlike in the past, when we spoke to interns, like the rest of the lobbyists.

<u>Property Tax Cap</u>: a very controversial idea of Gov. Spitzer's to cap

all property tax.
This would result
in a drop in revenue over time.
Both Assemblyman Oaks and

Sen. Nozzolio are not in favor, but we are watching to see if Patterson renews this idea. NYSUT needs your help to challenge this idea. Tell your legislators to vote "No". There are other ways to save money. Tax caps are already causing layoffs in Oswego County schools.

SRO's: Fight the loss of SRO's. It's not to save money, it's to put more uniformed police in urban

crime areas (Project Impact). We lose a valuable resource. Senator Nozzolio has stepped up and spoken out to keep SRO's. Bob Oaks believes it is a shift of resources to urban areas from rural, and most of his constituents are rural.


